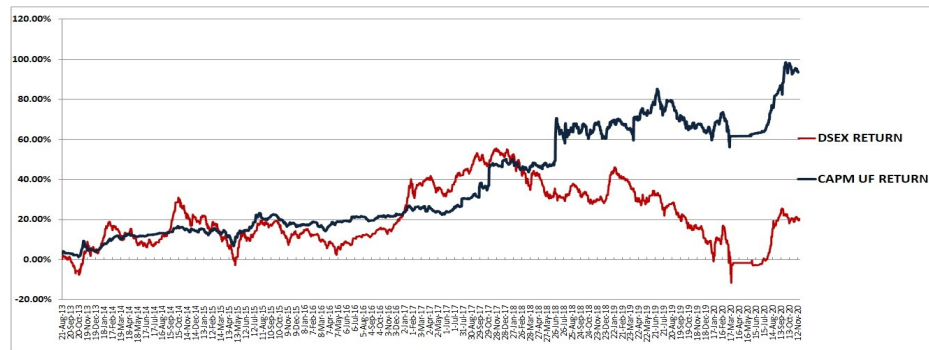
Investment Objective

Performance of the Fund Since Inception



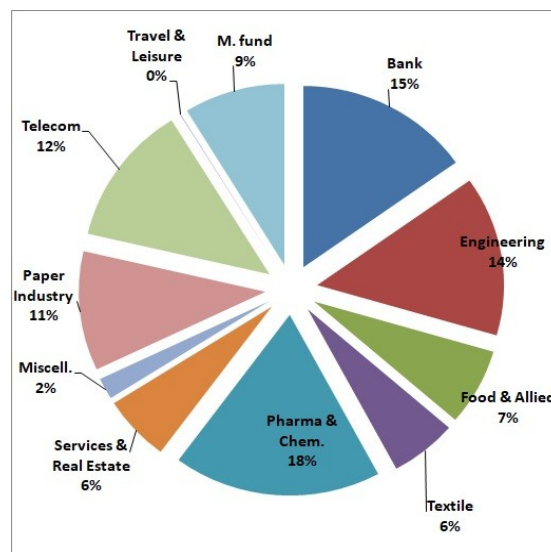
